

August 1, 1969

Lenhert Family Reunion Business Meeting

Myron Lady, president, called the meeting to order at 8:45 P. M., and led in opening prayer. The minutes of the 1966 reunion business meeting were read and approved.

A motion was made by Alvin Heise, and was duly seconded, to have a reunion in three years. There was active discussion about two questions, namely, do we want a reunion in two years, do we want a reunion at all.

Uncle Paul Lenhert moved to amend the motion to hold another reunion in two years. This motion was supported and the amendment was voted on by a show of hands. This amendment was unanimously defeated. A supported motion was made that the family vote by secret ballot on the main motion, whether to have a reunion in 3 years; each family unit was to cast one ballot and to indicate the number of individuals in the family unit. The president ruled that that was to be the method of voting on the main motion. Result: 15 yes votes for a reunion, 3 no votes. The total number of individuals involved in the yes and no votes could not be accurately determined since the ballots were destroyed before they were tabulated. The secret ballot papers were picked up by the new executive committee upon their being elected.

The next item of business was an announcement by Aunt Mary Lenhert that 6 new babies and 2 weddings had occurred since the last reunion. Aunt Mary then announced the prophecy (her head being covered by Galen with a paper napkin). The prophecy by various members of the family ranged from 6 to 15 births and from 1 to 4 marriages. Sam Lenhert had prophesied exactly right with 6 births and 2 marriages. Four persons tied for second place in their prophecies: Aunt Gladys Lenhert predicted 6 births and 3 marriages, David and Martha Eshelman had each guessed 6 births and 1 marriage, and Kenny Heise estimated 7 births and 2 marriages.

The third item of business was the election of officers. Alvin Heise presented a motion, which was supported, that the newly elected vice president advance to the office of president for the following reunion. Galen Lenhert presented an amendment which was supported to call the secretary-treasurer by the name of executive secretary. After much haggling and muttering by various spokesmen, Al's motion was withdrawn.

Sam Brubaker then made a supported motion to elect these three officers: president, vice president-president elect, and secretary-treasurer. The motion passed with a vote of 16 in favor, 5 opposed.

The nominees for president were Dale Lenhert, Sam Brubaker, Alvin Heise, and Uncle Paul Lenhert. The first vote resulted in a plurality; the final vote between Uncle Paul Lenhert and Al Heise resulted in the election of Alvin Heise.

Nominees for vice president-president elect: Sam Brubaker and Dale Lenhert. Dale Lenhert was elected as the vice president-president elect.

Nominees for secretary-treasurer: Donna Lenhart, Fern Heise, Ruth Engle, Sam Brubaker, Sara Lenhart, Lois Beachy, and Aunt Rhoda Lenhart. There was a plurality on the first vote. The president offered the two nominees with the highest votes who were Aunt Rhoda and Ruth. Ruth requested that her name be withdrawn from the ballot. The president suggested that we take her request into consideration when voting. The final vote resulted in the election of Aunt Rhoda.

Uncle Paul's supported motion to give these officers a vote of confidence to select the place for the next reunion passed by voice vote with no dissenting votes.

Uncle Ben made a motion to vote on the question, "Do we like this type of accommodations such as Mountainside Lodge at YMCA of the Rockies?" A vote on the question resulted in approval with no voice votes dissenting.

Jess made a supported motion to assess each member \$1. to cover next reunion expenses. Uncle Paul presented a substitute motion which was seconded, to collect a free-will offering for this purpose. This substitute motion was accepted and passed.

David made a motion and it was duly seconded that we have a separate gratuity fund from the Lenhart treasury fund. There was a suggestion to put out a box in which money for the gratuity fund could be dropped. The motion passed.

The chairman announced that there would be a gratuity box available for the family. The chairman further announced that the offering for the Lenhart treasury fund would be collected at the Hootenanny next day.

The chairman asked, "Is it time to quit?" and announced that there was pie in the dining room. The meeting was hereby dissolved.

An offering was taken for operating expenses for the next 3 years. It came to \$61.20. It was decided the Sunday morning offering was to be sent to Martha and Mary Olive Lady in Africa.

August 3, 1969

Sunday Morning Worship Service

The offering came to \$204. This was to be mailed to the Board for World Missions and divided evenly between Mary Olive Lady and Martha Lady.

A box for gratuity fund was set on a window sill throughout Sunday. The free-will collection amounted to \$35.

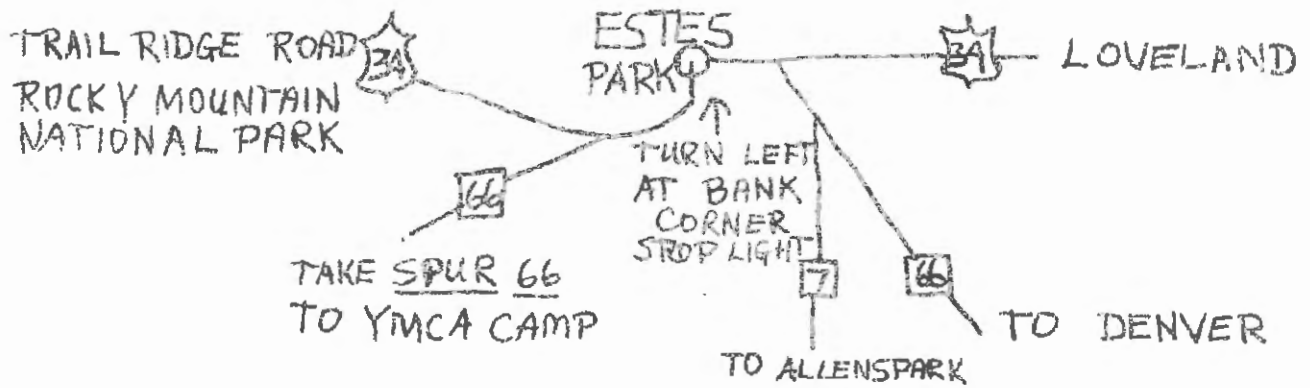
