At the 1985 Lenhert Family Reunion three officers were elected, and an additional four members were designated to serve on an advisory council, and Sam and Lucy designated as "special council to the council." Since you are one of these fortunate persons, I am asking for your reactions and suggestions regarding the future activities of the clan.

One of the primary objectives I set for the interim between the 1985 and 1988 reunions was to publish a family newsletter twice a year. With this letter is the fourth such newsletter, with the first three being circulated within the first year after the 1985 reunion.

The main questions to be addressed regarding the newsletter are: should it continue, and if so, how should it be financed. There was no money designated at the conclusion of the 1985 reunion for any future activities, and the cost of publishing each newsletter comes to about \$ 35.00. The costs are about \$ 10.00 for postage (45 family units @ \$.22 each), \$ 22 for photocopy services, and \$ 3.00 for miscellaneous expenses. That comes to almost \$.80 per mailing for each issue of the newsletter.


One possiblity is to have subscriptions, so that those who want the newsletter could simply pay \$6.00, the approximate cost for their newsletters between the 1985 and 1988 reunions. add extra money for any fundamental and extra money fundamen
