News from Somalia - Barbara & Lamar Witmer

The following was excerpted from a letter written to Dave Eshelman, who forwarded it to the newsletter editor.

Bob Barrett is an Assistant Professor of Engineering at Messiah College, where he has been teaching for 22 years. He really likes the great challenge of Messiah and the shepherding of the engineering students, "but it is much work". Bob is also involved with the missions group, World Christian Fellowship. He likes to sail his 14 1/2 foot sail boat. Racing really turns him on. Also, Bob is getting involved with white water canoeing and rafting. David, his youngest son, is in engineering at Messiah College and enjoys his studies. He toured the U.S. and Europe this summer with Continental Singers.

Joanne Barrett, mother of three grown children, has now left her job as morning dining room supervisor (five years) and is returning to part-time nursing at Messiah Village. She is now writing music with Dwight Thomas and expecting to release a new musical for children from Lillenas Publishing Co. called "Who's in Charge?" (story of Gideon). She is also busy writing to Linda, currently with Operation Mobilization in India, and Rob, newly graduated from Eastman School of Music and currently job hunting in Minneapolis. Husband Bob is teaching college again, and a new era of togetherness is developing in a nearly empty nest.

Our bedroom and Isaac's bedroom are at the side of the house toward the breeze (facing the ocean), so we can stay more comfortable in them.

"Isaac is sitting on the back of my chair, his back to me and his legs hanging over the edge. He's at the stage that he likes to be close by and frequently crawls over us, sticking his finger in our mouths, pulling our hair, etc. He does play pretty well by himself, too.

Minutes of the 1988 Lenhert Business Session

President David Eshelman called the meeting to order at approximately 7:00 p.m. on Tuesday, August 9, 1988. Dave expressed thanks to Myron Lady (vice-president) and Aunt Norma Lenhert (secretary/treasurer) for their part in reunion committee work during the last three years. The minutes of the 1986 reunion were approved as printed in the Lenhert Newsletter.

On behalf of the futures committee, Al Heise made a motion to hold another George H. Lenhert family reunion at Bear Trap Ranch in three years. This motion was seconded and passed unanimously with little discussion. An amendment to give latitude for the time of year and location to the new executive committee was made, seconded and passed. The following slate of officers for the ensuing triennium was presented and subsequently approved unanimously: Joanne Barrett, president; Bob Yiengst, vice-president; Karen Haldeman, secretary/treasurer.

Some family members stated that they have a preference for holding the reunion in late July instead of early August. The executive committee will take this into consideration.
